

Illinois Council on Long Term Care Skills Training for Psychiatric Rehabilitation

Seminar Purpose

An essential component in the psychiatric rehabilitation program for persons with Serious Mental Illness (SMI) in long term care is Skills Training. Skills Training is required in the Illinois Department of Public Health regulations Section S, 300.4050 for residents with SMI, and is also included as a reimbursable item in the MDS-based Medicaid reimbursement system.

To be able to have Skills Training groups in your facility, the individual conducting the sessions must attend an all-day approved Skills Training Group Leader program. This is an essential requirement for receiving reimbursement credit on the Illinois MDS Medicaid system.

This training session is a hands-on, role-playing seminar for the individuals who will actually be leading the Skills Training groups, such as a Psychiatric Rehabilitation Services Coordinator, a Psychiatric Rehabilitation Services Aide or others.

Essential group leader skills will be discussed, and participants will learn and practice the seven learning activities used to teach residents new skills. Practical information on how to set up a Skills Training program and organize groups will also be provided, including writing care plan goals for Skills Training and required weekly documentation. **Because there will be small group practice and role-playing, the seminar for each of the sessions is limited to the first 30 participants.** Any registrants beyond the first participants will be notified of alternative dates and locations, or have their registration fee refunded.

This seminar will be relevant for Administrators, Social Workers, Psychiatric Rehabilitation Services Directors, Psychiatric Rehabilitation Services Coordinators, Psychiatric Rehabilitation Services Aides, and other facility staff who will be directly conducting or supervising Skills Training group sessions for residents with Serious Mental Illness.
